GETTYSBURG

Little Round Top is the smaller of two rocky hills south of Gettysburg, Pennsylvania. It was the site of an unsuccessful assault by Confederate troops against the Union's left flank on July 2, 1863, the second day of the Battle of Gettysburg. When Union General Meade discovered there was going to be a Confederate advance on Little Round Top, he dispatched his chief engineer, Brigadier General Gouverneur K. Warren, to attempt to deal with the situation. Climbing Little Round Top, Warren found only a small Signal Corps stationed there. Warren encouraged the signal men to remain at their post and keep waving flags while an aide galloped off to find any Union troops he could locate to get them to the hill. The Union prevailed.
